Provided that if a candidate studies outside Assam from class-VII onwards because his/her father/mother is posted outside Assam as an Assam State Government employee or as Central Government Employee or as an Employee of a Corporation/Agency/Instrumentality under Govt. of Assam or Central Govt. whether on deputation or transfer or regular posting, then the period for which the said father/mother is working outside the State be relaxable for such candidate.
