**EDUCATIONAL NOTICE**

Application are invited from the eligible candidates who have appeared in the All India AYUSH Post Graduate Entrance Test (AIAPGET-2020), for counseling for admission into MD/MS (Ayu) course in the subjects namely (i) Ayurved Samhita & Siddhanta, (ii) Kayachikitsa, (iii) Prasuti Tantra & Stree Roga, (iv) Rachana Sharir (v) Roga Nidan & (vi) Shalya Tantra, at Govt. Ayurvedic College, Guwahati for the session 2020-21, against the state quota, Central Govt. Nominee Quota and NEC quota seats.

Due to prevailing COVID-19 pandemic, the Ministry of AYUSH, Govt. of India, vide letter no. L-14011/18/2019-EP-1 dated 08/12/2020, decided to extend the last date/cut-off date for completion of internship up to 31<sup>st</sup> December, 2020 to be eligible for admission into ASU & H PG courses for the academic session 2020-21. However, the candidates must have been started their one year rotatory internship on or before 1<sup>st</sup> November, 2019.

The selection of the candidates for admission into MD/MS(Ayu) course at Govt. Ayurvedic College, Guwahati, will be done through counseling which will be held as per the schedule mentioned below. The candidates are to appear before the Selection Board for counseling for selection, subject to fulfillment of the eligibility criteria.

In absence of the Government candidate nominated by the Ministry of AYUSH, Govt. of India, the vacant seat/seats will be filled up by the Private candidates sponsored by the deficient States/UTs under Central Government Nominee seats as per the guideline of Ministry of AYUSH, Govt. of India for Central Government Nomination to MD(Ayu) for the session 2020-21.

In absence of the Private candidates sponsored by the deficient States/UTs, the vacant seat/seats will be filled up by the open category candidate/candidates applied under state quota seats on basis of the merit of AIAPGET-2020, subject to fulfillment of the eligibility criteria.

To be eligible for state quota seats, the candidate must be a citizen of India and his/her parent must be permanent resident of Assam.

For NEC quota, the candidate must submit the duly filled up "Application Form" along with the certificate in Annexure-I with necessary signature as noted thereon.

Candidates are requested to appear personally before the Selection Board along with all relevant documents, testimonials etc. in original on the scheduled date and time as mentioned above, failing which he/she will forfeit the merit position and no claim shall be considered later on.
