2. PROCEDURE, TERMS AND CONDITIONS,

- **a.** The EOI is to be submitted on single bid basis i.e. Technical Bid.
- b. The Bid needs to be submitted in a sealed envelope super scribing
 "Expression of Interest (EOI) for running Yoga and Wellness
 Centre under National AYUSH Mission Assam".
- **a.** An amount of Rs. 10,000/- (Ten thousand) only will have to be deposited in the form of Demand Draft drawn on any nationalized/ schedule bank of India in favour of "State AYUSH Society, Assam" payable at Guwahati as EMD with the technical bid. No Bank guarantee will be accepted in lieu of the EMD. The EMD of the unsuccessful bidders would be returned after award of the contract.
- c. Bid responses must be addressed to the Director AYUSH, Assam & Member Secretary (EB), State AYUSH Society, 3rd Floor, Saikia Commercial Complex, Christianbasti, Guwahati – 5.

- **d.** National AYUSH Mission, Assam reserves the right to solicit additional information from Bidders.
- **e.** National AYUSH Mission, Assam reserves the right to accept the whole, or part of or reject any or all bids without assigning any reasons thereof.

3. ELIGIBILITY CONDITIONS:

- **A.** The Bidders should fulfil the following eligibility conditions for participating in the Expression of Interest (EOI). The bidders should enclose documentary evidence for fulfilling the eligibility conditions:
 - a. Bidder (NGO/Agency) should have a registered local office in Assam
 - b. Bidder should not have been blacklisted by any of the State or Central Government organization. Should not have been found guilty of any criminal offence by any Court of Law.
 - c. The cumulative turnover of the NGO/ agency in the area of promotional activities of Yoga along with the revenue generation during the last three FY should be minimum Rs. 15 lakhs.
 - d. The agency must have an experience of running at least two Yoga Institute/ training centre with minimum 20 participant each on daily basis for at least 3 years
 - e. The agency must have adequate manpower & infrastructure for management/organize yoga training etc.
 - f. The NGO/ Agency should have sufficient qualified Yoga professionals to impart yoga training to common people / patients.

B. CREDENTIALS

Only organizations having the following credentials are requested to respond:

a. Organizations having Yoga teacher with minimum qualification of diploma in Yoga (1 year duration) from recognized institutions certified by Govt. of India/Universities. The organization should have at least 3 qualified Yoga Instructor/Teachers (at least one female) under it against one Yoga & Wellness Centre. (Attested copies of certificate of qualification of the Yoga Instructor/Teachers under the organization to be submitted).

b. Organizations should also have the capacity to provide AYUSH Consultancy services monthly in the form of health check-up, counselling, life style modifications, Ayurveda & Homoeopathy treatment etc.

4. SCOPE OF WORK

- **a.** The NGO/ Agency have to run the Yoga & Wellness Centre in the identified institution as per modalities/ guidelines of NAM Assam and instruction issued time to time.
- **b.** There will be two sessions of yoga training to patients / common people and related activities in a day (morning session for 2 hours and evening session for 1 hour minimum). Time table may be scheduled as per need of the centre.
- **c.** The NGO/ agency will organize AYUSH Consultancy service in the form of free Medical & Health Check-up camps monthly in the Institute or adjoining area.
- **d.** The NGO/ agency shall only engage the requisite qualified and experienced Yoga Instructor (Male & Female) and Assistant cum Cleaner in the Yoga Centre.
- **e.** The Yoga training will adhere to the "Common Yoga Protocol" issued by Ministry of AYUSH, Govt. of India from time to time and other guidelines issued by the Govt. of Assam/Govt. of India.
- f. Yoga fest/ yoga competition/ lectures by eminent Yoga person/ International Day of Yoga etc. may be organised.

6. HUMAN RESOURCE:

Each selected NGO/ agency shall provide the following Human Resource in each centre:

- **a.** Yoga instructor: 2 nos. (1 male, 1 female). The educational qualification of Yoga Instructor is preferably Diploma in Yoga therapy or above from any recognised institution.
- b. Assistant-cum-cleaner: 1 no. Educational qualification: Class- VIII Pass.
- **c.** Registered Ayurvedic and Homeopathic practitioners for monthly AYUSH Consultancy services.

The NGO/ Agency will have to submit the bio-data of the Yoga instructors and Assistant cum cleaner to be engaged in the centres if selected. In case of change in human resource in the centres prior approval of the bid inviting authority will be required.

7. TARGET GROUP

- **a.** Patients
- **b.** Health workers,
- **c.** Common people,
- **d.** Jail imamates (in case of jails)

8. FUND INVOLVEMENT:

Total fund involvement for each Yoga & Wellness Centre will be Rs. 5.40 Lakhs per annum.

9. PAYMENT:

Payment will be done quarterly (Financial Year basis) on receipt of necessary reports and bills duly signed and forwarded by the Institutional In-charges of the centres. .

10. PERIOD OF CONTRACT:

The contract will be initially for a period of 1 (one) year from the date of award of the work. The contract may be extended for the subsequent years on the basis of performance / appraisal report.

Either party reserves the right to terminate the contract with serving of one month advance notice.

11. AMENDMENT OF EOI DOCUMENT:

At any time before the submission of bids, National AYUSH Mission, Assam may amend the EOI document by issuing an addendum/corrigendum in writing or by announcing it through newspaper or website. The addendum/corrigendum shall be binding on all the NGOs/ agencies. In case of any amendment the last date of submission of the bid or part document may be extended to give the NGOs/ agencies reasonable time.

12. PENALITY CLAUSE

- **a.** An Agreement to be signed by the successful bidders with Sate AYUSH Society, Assam. Any breach in the agreement will lead to penalty and later termination of the contract.
- **b.** If at any given point of time it is found that the bidder has made a statement which is factually incorrect or if the bidder doesn't fulfil any of the contractual obligation, the EOI inviting authority may take a decision to cancel the contract with immediate effect. Further, the EMD of the agency may also be forfeited.

14. APPLICABLE LAW AND JURISDITION:

This contract, including all matters connected with this contract, shall be governed by the Indian laws, both substantive and procedural, for the time being in force and shall be subject to the exclusive jurisdiction of Gauhati High Court, if required.

15. SIGNING OF BID:

The original bid and all documents of the Bid shall be typed or written in a legible hand writing and shall be signed by the Bidder or a person duly authorized to sign by the Bidder with official seal. The person or persons signing the Bid shall initial all pages of the Bid.

16. BID SUBMISSION:

- a) Bidders must submit their bid in sealed envelopes super-scribed "Expression of Interest (EOI) for running Yoga and Wellness Centre under National AYUSH Mission Assam".and addressed to "the Director cum Member Secretary (EB), National AYUSH Mission, Assam". The name, address with mobile no of the bidder should be written legibly on the sealed envelope.
- b) Technical Bid should contain
 - i. One indexed checklist of the submitted documents in the bid.
 - ii. Court fee stamp of Rs. 8.25 affixed
 - iii. EMD in the form of DD/BD
 - iv. Self-attested copies of valid Certificate of Incorporation/Partnership deed (Notarized)/ Society Registration/ Proprietorship declaration (Notarized), Trade License, Labour License, PAN and GSTIN (as applicable).
 - v. Office address proof.
 - vi. Agency Profile with Manpower & Infrastructure Details (organogram).
 - vii. Proof of Turnover for last 3 financial years audited and certified by Chartered Accountant.
 - viii. Documentary evidence of past 3 years experience in running Yoga Institute/ Centers.

- ix. Details of qualified Yoga professionals available with the NGO/Agency. (in enclosed format)
- x. Self declaration certificate for non-blacklisting (Notarized)
- xi. The bidder must submit copy of complete EOI Document with sign and seal of bidder on each page.
- xii. The bidder must sign and affix seal on every page of submitted documents.

17. EVALUATION CRITERIA

- a) Bids will be opened initially as per prescribed schedule and evaluated for technical eligibility.
- b) Only those bidders scoring minimum 60% and above in technical evaluation will be declared responsive and eligible.
- c) No conditional bid will be accepted.

18. SELECTION:

The NGOs/ agencies would be selected on merit of the technical evaluation criteria. Out of the total 35 nos. of Yoga & Wellness Centres, the allotment of number Yoga centres to a NGO/Agency will be done on the basis of the ranking of the technical bid.

- 1. 1st rank holder shall be awarded 11 nos. of Yoga & Wellness Centres.
- 2. 2nd rank holder shall be awarded 9 nos. of Yoga & Wellness Centres
- 3. 3rd rank holder shall be awarded 7 nos. of Yoga & Wellness Centres

- 4. 4th rank holder shall be awarded 5 nos. of Yoga & Wellness Centres
- 5. 5th rank holder shall be awarded 3 nos. of Yoga & Wellness Centres

The above number of centres may vary depending on the time of initial establishment of the Yoga and Wellness Centres.

Director AYUSH cum Member Secretary (EB), State AYUSH Society, Assam reserves the right to allocate the number of Yoga & Wellness Centres in the interest of smooth functioning of the centres.

In case, if sufficient suitable service provider is not found, the Authority may recommend the Yoga & Wellness Centres on proportional basis to the eligible service provider.
