#### **Technical Bid**

- Detailed rates duly signed by the authorized person giving full name, address and contact telephone nos. etc. needs to

   be furnished by the stipulated time and date.

### (Terms & Conditions)

- Inadequate or incomplete tenders in any respect or the prescribed conditions not fulfilled are liable to be rejected.
   Canvassing in any form by the tenderers/vendor will result in rejection of their tenders.
- 2. Detailed specification of required item should clearly be mentioned in the quotation. Quotations not containing samples will not be considered. Other detail such as warranty, delivery period if any & tax provision etc. if required shall also be intimated.
- 3. Copies of orders/letters of major organizations/Government Departments with which the tenderer has dealt/supplied such products during last financial year shall be furnished by the tenderer/vender.
- 4. The tenderer/firm must submit the copies of TIN/PAN Number etc.
- 5. All complaints, which may be indefinite, shall be attended immediately during entire warranty period.
